## Legal Search

Allows you to search on specific parameters

- Date

## Act Search

Allows you to search for the Act based on full or partial information that you may have. If you do not know the name of the Act you can run a Free Text Act Search.

## Citation Search

The database covers equivalent citations of multiple print journals thus making reference to printed copy easier. The search interface allows you to search even if you have partial information.

## Free Text Search

Assists you in searching for key words, phrases, multiple phrases, words near each other (proximity search). Enables Boolean Search using terms and connectors such as 'and', 'or', 'not' and more...
